The Bertie County Commissioners met in Regular Session at 6:00 PM inside the Commissioners' room, 106 Dundee Street, Windsor, NC. This meeting was hosted partially in person and partially via Zoom (conference call). The following members were present or absent:

CALL TO ORDER

Chair Corey Ballance, Sr. called the meeting to order.

INVOCATION & PLEDGE OF ALLEGIANCE

Commissioner Ronald Roberson gave the Invocation and led the Pledge of Allegiance.

PUBLIC COMMENTS

Eunice Ward shared her concerns regarding unsecured dangerous dogs in her yard.

Miles Davis expressed concerns about Bertie County missing out on state funding for port and harbor development compared to neighboring counties.

Lydra Freeman, the newly appointed jail administrator, provided an update on recent jail improvements and maintenance work. Ms. Freeman also reported successful sanitation and jail inspections with minor violations, thanking the Jail Board Commission for their efforts.

1. Municipal Election Updates by Director LaToya Peele

Elections Director LaToya Peele provided details on the upcoming 2025 municipal election, including voter registration deadlines and early voting options for eligible residents.

2. Council on Aging Updates by Director Rebecca Stapleton

Council on Aging Director Rebecca Stapleton shared updates on the Council on Aging, highlighting partnerships, events, and services for seniors, while also addressing the impact of the government shutdown on meal services and in-home aid. Mrs. Stapleton stated that the government shutdown has affected the home delivered meals to Bertie County citizens because of the funding delays and asked for continued support from the County.

3. Update on Community Services Endeavors by Members of the Divine Nine Organizations

Members of the Divine Nine organizations, including Alpha Kappa Alpha Sorority, Kappa Alpha Psi Fraternity, Omega Psi Phi Fraternity, and Delta Sigma Theta Sorority, presented their community service initiatives and goals. The group also highlighted their national programs and community impact.

3. Inclement Weather Policy

The Commissioners and County Manager discussed the three options for the Inclement Weather Policy that was provided by HR and Risk Management Director Nicole Boone. The three options were: Administrative Leave, Inclement Weather Leave, or for employees to use their available leave.

County Manager Vaughan stated that he did not want to take away any benefits from employees and suggested to maintain the current policy regarding employee leave during inclement weather closures which is Administrative Leave, with an option to require leave for extended closures of more than 5 days.

Commissioner Roberson made the **MOTION** to approve the use of Administrative Leave for the Inclement Weather Policy with an option to require leave for extended closures of more than 5 days. The **MOTION** was **SECONDED** by Commissioner Saunders. The **MOTION PASSED** with a **5-0** vote.

Commissioner Saunders informed the citizens that the Tourism Development Board will have its next meeting on Tuesday, October 7, 2025.

Chair Ballance

Chair Ballance recognized the Blue Jay Recreation Department for the well planned and organized Bertie County's Forgotten Black and Native Patriots of the Revolutionary War program that was held on October 4 – 5, 2025. Chair Ballance stated that he attended the Aulander Harvest Festival that was held on October 4, 2025 and had a wonderful time.

County Manager Vaughan reminded the Board of the planned Employee Appreciation Luncheon to be held on Thursday, December 4, 2025 along with the County's Spirit Week that is the week of December 1 – 5, 2025. 
CLOSED SESSION


ADJOURN
