## Windsor, North Carolina August 4, 2025 REGULAR SESSION

# CALL TO ORDER

Chair Ballance called the meeting to order.

#### **INVOCATION & PLEDGE OF ALLEGIANCE**

Vice-Chair Hoggard gave the Invocation and led the Pledge of Allegiance.

#### **PUBLIC COMMENTS**

Finance Director, Willie Mack Carawan, provided updates on addressing outstanding audit items and internal control policies, including noncompliance with the Department of Environmental Quality (DEQ).

Brenda Frick expressed her concerns regarding the \$841,000 county deficient shortfall, county jobs not being filled, and the audit reports not being done in a timely manner. Mrs. Frick stated that the county should not be going through this.

Tuesday Sauer stated that the \$841,000 deficient shortfall is disappointing and to hear that the Sheriff's Department received a 15% raise increase when there is a shortfall in the budget is unacceptable. Mrs. Sauer mentioned numerous other concerns that she had including the county being noncompliant with DEQ.

Jean Kozachuk spoke about her concerns with included the county's financial disasters, the Merry Hill EMS station, dangerous waters at Bertie Beach, and the solar farm project.

Michelle Glliam stated that she is a citizen of Lewiston-Woodville and has purchased a trail park in the area and would like to know if there is an ordinance for abandoned vehicles and property.

Jerry Cowand stated that there is a lack of communication and information between the county and citizens. Mr. Cowand expressed his concerns about the occupancy tax increase to 6%.

Deborah Tayloe, a Bertie County resident, expressed concerns about declining property values and the need for stronger countywide standards to address issues like litter and abandoned properties, emphasizing the importance of attracting new residents and businesses.

Robert Jordan, highlighted the impact of the 6% occupancy tax on small businesses and suggested a more reasonable rate at 3%, while also voicing concerns about reduced convenience sites hours.

Rusty Walton raised issues with the proposed animal shelter design, advocating for more space for dogs to exercise.

Finance Director, Willie Mack Carawan, provided the Board with a financial summary that showed a decrease in bank account balances because of large payments for fire trucks, but stated that revenues exceeded expenditures in the general fund. Mr. Carawan presented the DEQ Grant and ARPA Funds requirements to the Board. Mr. Carawan also informed the Board that DEQ requires an Internl Control Policy to be put in place by the county in which he will present to the Board at the next meeting for approval.
