## I. ANNOUNCEMENT

The County of Bertie, North Carolina, requests statements of qualifications from Architectural/Engineering firms (hereafter referred to as A/E firms) to provide full design and construction administration services for a new Bertie County 911 Center. Bertie County has been awarded a grant from the North Carolina 911 Board (NC911) for partial funding of this construction project.

Qualifications are requested for the design of a 5,800 (approximate) square foot (SF) facility and construction administration services. The new facility will be located behind the existing EMS Station at 206 County Farm Road, Windsor, NC. The facility will be used for County 911 operations and will house offices and training space.

An authorized County representative will receive qualifications until 2:00 p.m. (local time) on Friday, March 1, 2024. **Qualifications received after this date and time will not be accepted.**Qualifications shall be enclosed in envelopes that clearly indicate "RFQ 2024-111 911 Facility, Qualifications for A/E Services."

A/E firms will be required to meet the qualifications set out in this Request for Qualifications (RFQ) document, which include the following:

- Experience in the design and engineering of critical infrastructure, preferable 911
   Centers/Emergency Operations Centers (EOCs)
- Experience in grounding and robust lightning protection
- · Current errors and omissions insurance
- Ability to provide a qualified and experienced team
- Ability to work as a team with the County stakeholders and Mission Critical Partners, LLC (MCP), the County's consultant for the project

## II. INSTRUCTIONS TO FIRMS

- A. Preparation of Qualifications
  - 1. Firms are expected to comply with all specifications, terms, conditions, and instructions contained within this RFQ. Failure to do so will result in statement rejection.
  - 2. Qualification packages shall be prepared with brevity, providing a concise description of a respective firm's capabilities to satisfy the requirements of this RFQ. Emphasis should be

placed on completeness and clarity. Each copy, and all documentation submitted, should be bound into a single volume. The County will not be responsible for any costs incurred by firms in preparing or presenting qualifications.

## C. Number of Copies

A/E firms shall furnish one (1) original bound and four (4) bound hard copies of the qualification packages, as well as one (1) .pdf copy of the qualification package on a Universal Serial Bus (USB) drive.

## D. Form of Agreement

The Form of Agreement to be used shall be the "Standard Form of Agreement between Owner and Architect, AIA B101-2017."

## III. A/E FIRM QUALIFICATIONS

Firms submitting qualifications shall:

- A. Be knowledgeable of all current federal, state, and local applicable statutes and codes related to building projects in North Carolina.
- B. Maintain professional liability insurance with minimum coverage as stated in the Standard Form of Agreement Between Owner and Architect AIA A101 and as outlined by the County.
- C. Ability to prepare and submit to the appropriate state and local approval agencies all necessary documents in proper form and in a timely manner.
- D. Directly employ in-house personnel to perform 75 percent of the actual architectural work.

E. Provide, in the qualifications package, 911/EOC or critical infrastructure projects in the past five years to include current references for the projects presented.

## IV. REQUIREMENTS OF THE SELECTED A/E FIRM

The A/E firm must work with all stakeholders involved and MCP through the completion of this project. The project scope and services shall include, but are not necessarily limited to the following:

- A. Architectural design services.
- B. Preparation of bid list.
- C. Preparation of construction specifications, CAD drawings, and other formal bidding documents for the project to be sent to construction firms and formally bid per North Carolina statutes.
- D. Bidding phase assistance.
- E. Work in a coordinated fashion with MCP.
- F. Review construction bids.
- G. Construction administration to include meeting facilitation and regular site observations of the contractor and subcontractors during the construction phase.
- H. Cost estimating.
- Complete design services including plumbing, mechanical, and electrical (MEP) and heating, ventilation, and air conditioning (HVAC) engineering services plus any other necessary subcontract services.
- J. Construction signoffs to assure that scheduled payments are made, with appropriate holdbacks, when predetermined work has been completed.
- K. Ensuring requisite approvals and any necessary permitting have been gained (e.g., County Fire Marshal inspections, City/County building inspections).
- L. Final project signoff, assuring that the finished product represents what was captured in the construction documents.
- M. Project close-out, including warranty phase administration, and ensuring requisite owner manuals are provided to the County.

## V. SELECTION OF FIRM

The County reserves the right to reject any or all qualifications received, cancel the project, or reissue the RFQ if necessary. The County and its consultant will evaluate submitted qualification packages and may conduct interviews with select firms.

Once an A/E firm is selected, a fair and reasonable fee will be negotiated with the selectee. If an acceptable fee cannot be negotiated, the County reserves the right to go to the next best qualified firm and begin negotiations.

## VI. PROJECT DESCRIPTION

The County seeks the services of a qualified A/E firm for the design of a purpose-built public safety facility, including the following departments and/or areas, and construction administration:

- County 911 operations center
- Staff offices, training, and conference space
- Data center
  - A. As 911 is considered critical infrastructure, in addition to industry standards, adherence to applicable standards (e.g., from the National Fire Protection Association [NFPA]), and guidance from the Federal Emergency Management Agency (FEMA) is imperative.
  - B. The selected A/E firm shall provide programming and an initial budget estimate; conduct schematic design and design development and provide construction and permitting documents; bid the project under North Carolina bidding requirements; and provide construction administration services per the AIA B101-2017 documents. Project oversight will be provided by MCP.
  - C. The selected A/E firm shall maintain the construction budget as part of the services provided to the County.

## VII. PROJECT SCHEDULE

A three-year schedule is required for the project. Adherence to the schedule is a primary goal of this RFQ as various state and local deadlines are placed on the County. The proposed project timeline is as follows:

A. RFQ Issued February 5, 2024

B. RFQ Questions Deadline (5:00 PM) February 16, 2024

C. Qualification Packages Due March 1, 2024 (Firms may be shortlisted for oral interviews following submission)

D. Interviews (if necessary) week of March 18, 2024

E. Board of Commissioners approval of A/E contract April 8, 2024

F. Grant project closeout date not to extend beyond December 30, 2026

## VIII. SUBMISSION REQUIREMENTS

A/E firms are required to provide clear and concise answers to the RFQ requirements described below. It is preferred that each section have its own tab in the bound proposal document previously described. Proposal content requirements are as follows:
